The consolidated financial statements of TV Thunder Public Company Limited and its subsidiaries ("the Company") for the three-month period ended June 30, 2016 (Quarter 2/2016) showed total revenue 136.70 million baht. Cost of sales and services amounted to 97.88 million baht. Selling and administrative expenses, other expenses and finance costs were 22.77 million baht. Total Net Income for the period was 14.32 million baht, which increased by 3.61 million baht or 33.69% in the same quarter of the previous year. This changes can be explained primarily due to:

Revenues:

For the 2nd quarter ended June 30, 2016 the company had the total revenue of 136.70 million baht increased by

14.23 million baht or 11.62% from the 2nd quarter ended June 30, 2015 which had the total revenue of 122.47 million baht.

The performance can be summarized as follows:

Revenue from advertising

For the 2nd quarter ended June 30, 2016 the company had the revenue from advertising of 99.27 million baht

which decreased by 6.10 million baht or 5.79% from the same quarter of the previous year. The decrease of revenue mainly

came from customer delay to spend their advertising budget in the early years due to the sluggish economy and the

competition of digital TV had effected to advertising price index.

Revenue from services:

For the 2nd quarter ended June 30, 2016 the company had the revenue from services of 37.44 million baht which

increased by 20.34 million baht or 118.96% from the same quarter of the previous year. The increase was due to the

continued growth in the production of service in digital TV and online platform.

Cost of sales and services:

For the 2nd quarter ended June 30, 2016 the company had the cost of sales and services of 97.88 million baht

which increased by 11.14 million baht or 12.85% from the same quarter of the previous year. This was mainly due to the

high production cost in some program.

Selling and Administrative Expenses, Other Expenses:

For the 2nd quarter ended June 30, 2016 the company had the selling and administrative expenses and other

expenses of 22.77 million baht decreased by 1.04 million baht or 4.37% from the same quarter of the previous year.
