## Revenue:

In quarter 3/2021, the company had total revenues of 48.64 million baht, decrease by 27.51 million baht or 36.12% from to same period of the previous year mainly due to a decrease of advertising revenue 0.54 million baht or 1.74% and decrease of service revenue of 26.97 million baht or 67.78% from to same period of the previous year.

The decrease in service revenue in the 3rd quarter of 2021 amounted to 26.97 million baht, mainly due to the COVID-19 situation in 2021, causing the production to be suspended. As a result, the company was unable to deliver the work as scheduled in this quarter.

## Cost of sales and service:

In quarter 3/2021, the Company had total cost of goods sold of 30.35 million baht, decreasing by 19.96 million baht or 39.68% from to same period of the previous year, due to the production cannot be shooted cause of COVID-19 situation.

## Distribution costs and administrative expenses:

In quarter 3/2021, the Company had total distribution costs and administrative expenses of 23.05 million baht, increasing by 4.82 million baht or 26.43% from to same period of the previous year, this is an increase from the promotional cost. and expenditure on employees that the company has expanded more work segments
