The consolidated financial statements of TV Thunder Public Company Limited and its subsidiaries ("the Company") for the three-month period ended September 30, 2017 (Quarter 3/2017) showed total revenue 176.46 million baht. Cost of sales and services amounted to 126.46 million baht. Selling and administrative expenses and other expenses were 28.46 million baht. Total Net Income for the period was 22.92 million baht which increase of 8.50 million baht or 58.96% from the same quarter of last year. This changes can be explained primarily due to:

### Revenues:

For the 3rd quarter ended September 30, 2017, the Company had the total revenue was 176.46 million baht, which increased by 13.17 million baht or 8.06% comparing to the same period of the previous year which had the total revenue of 163.30 million baht. The performance can be summarized as follows:

## Revenue from advertising

For the 3rd quarter ended September 30, 2017, the company had total advertising revenue of 82.61 million baht which decreased by 26.82 million baht or 24.51% compared to the same period of 2016. This is due to declining advertising on analog TVs.

### Revenue from services

For the 3rd quarter ended September 30, 2017, the company had total of 93.86 million baht, which increased by 39.99 million baht or 74.23% comparing to the same quarter of the previous year. The increase was due to the growth of production.

### Cost of sales and services:

For the 3rd quarter ended September 30, 2017, the company had the cost of sales and services was 126.46 million baht which increased by 3.98 million baht or 3.25% comparing to the same period of the previous year. This was mainly due to the increased of production.

## Selling and Administrative Expenses, Other Expenses:

For the 3rd quarter ended September 30, 2017, the company had the selling and administrative expenses and other expenses were 28.46 million baht, which decreased by 0.16 million baht or 0.56% from the same quarter of the previous year.
