For the three-month period ended June 30,2017

The Stock Exchange of Thailand

The consolidated financial statements of TV Thunder Public Company Limited and its subsidiaries ("the Company") for the three-month period ended June 30, 2017 (Quarter 2/2017) showed total revenue 116.59 million baht. Cost of sales and services amounted to 92.04 million baht. Selling and administrative expenses and other expenses were 26.95 million baht, showing a net loss of 1.13 million baht which decrease of 15.45 million baht or 107.93% from the same quarter of last year. This changes can be explained primarily due to:

Revenues:

For the 2nd quarter ended June 30, 2017, the Company had the total revenue was 116.59 million baht, which

decreased by 20.11 million baht or 14.71% comparing to the same period of the previous year which had the total revenue

of 136.70 million baht. The performance can be summarized as follows:

Revenue from advertising

For the 2nd quarter ended June 30, 2017, the company had total advertising revenue of 65.86 million baht which

decreased by 33.40 million baht or 33.65% compared to the same period of 2016. This is due to declining advertising on

analog TVs.

Revenue from services

For the 2nd quarter ended June 30, 2017, the company had total of 50.73 million baht, which increased by 13.29

million baht or 35.51% comparing to the same quarter of the previous year. This is due to the increase in public relations

revenue, including concerts. "เพลงรักของคี้ คนตรีของแต๋ง".

Cost of sales and services:

For the 2nd quarter ended June 30, 2017, the company had the cost of sales and services was 92.04 million baht

which decreased by 5.84 million baht or 5.97% comparing to the same period of the previous year. This was mainly due to

the decreased in advertising program.

Selling and Administrative Expenses, Other Expenses:

For the 2nd quarter ended June 30, 2017, the company had the selling and administrative expenses and other

expenses were 26.95 million baht, which increased by 0.63 million baht or 2.41% from the same quarter of the previous

year. Mainly due to the increase of the expenditure on the personnel development.
