Subject: Management Discussion and Analysis

For the three-month period ended March 31,2019

To: The President,

The Stock Exchange of Thailand

The consolidated financial statements of TV Thunder Public Company Limited and its subsidiaries ("the Company") for the three-month period ended March 31, 2019 (Quarter 1/2019) showed total revenue amounted to 93.39 million baht. Total cost of sales and services amounted to 70.71 million baht. Selling and administrative expenses, other expenses and finance costs amounted to 26.26 million baht. Net Loss for the period attributable to the equity holders of the parent company was 4.01 million baht, which decreased by 7.26 million baht or 223.61% from the same quarter of the last year. This change can be primarily explained due to:

Revenues:

For the 1st quarter ended March 31, 2019, the Company had the total revenue was 93.39 million baht, which

increased of 6.84 million baht or 7.90% compared with the same period of the previous year which had the total revenue

of 86.55 million baht. The performance can be summarized as follows:

Revenue from advertising

For the 1st quarter ended March 31, 2019, the company had total advertising revenue of 39.05 million baht which

decreased by 1.47 million baht or 3.62% compared with the same period of the previous year. The decline was from

decrease in overall advertising spending budget from clients especially in Masterkey and Luang Ta Mahachon. However,

the advertising spending should be starting to slowly pick up in 2H of 2019.

Revenue from services

For the 1st quarter ended March 31, 2019, the company had total of 54.35 million baht, which increased of 8.30

million baht or 18.04% comparing to the same quarter of the previous year. The increase was from production business

unit which was attributed to new programs such as You Are My Fantasy, Sa Nae Ha the Series, The Attitude and Gang

Puan Duan Raca. But the event and communication business unit was decreased from the previous year.

Cost of sales and services:

For the 1st quarter ended March 31, 2019, the company had the cost of sales and services was 70.71 million baht

which increased of 12.42 million baht or 21.31% comparing to the same period of the previous year. The increase in cost

came from airtime cost in Take Me Out and cost from producing TV Programs.

Selling and Administrative Expenses, Other Expenses:

For the 1st quarter ended March 31, 2019, the company had the selling and administrative expenses and other

expenses were 26.26 million baht, which decreased by 0.39 million baht or 1.46% comparing to the same quarter of the

previous year. Mainly due to the better cost control in SGA.
