Revenue:

In quarter 2/2021, the company had total revenues of 68.06 million baht, increase by 10.14 million baht or 17.51% from to same period of the previous year mainly due to a increase of advertising revenue 15.47 million baht or 74.92% and decrease of service revenue of 5.33 million baht or 14.29% from to same period of the previous year.

The increase of advertising revenues in quarter 2/2021 was mainly due to increase in revenue from tie-in products in the programs

The increase in service revenue in quarter 2/2021 to 5.33 million baht, mainly due to an decrease in the revenue from the production of dramas In the previous year, there was a contract to produce a long-running drama with high income. But in the current year, there is revenue from the sale of copyright items that the company holds. to overseas buyers added.

Cost of sales and service:

In quarter 2/2021, the Company had total cost of goods sold of 46.56 million baht, increasing by 0.39 million baht or 0.84% from to same period of the previous year, this is a small increase as last year was able to save costs from tapes that were re-broadcast during the Covid-19 situation.

Distribution costs and administrative expenses:

In quarter 2/2021, the Company had total distribution costs and administrative expenses of 19.41 million baht, decreasing by 1.09 million baht or 5.30% from to same period of the previous year, this is a reduction in expenses related to employees, such as a temporary postponement of contributions to the provident fund. from the situation of COVID-19

Other expenses and discontinued operations:

In quarter 2/2021, the company recognize the reversal of the expected credit loss of 1.59 million baht.
