Revenue:

For the 3<sup>rd</sup> quarter ended September 30, 2019, the Company had the total revenue of 102.14 million baht, which decreased

by 42.37 million baht or 29.32%. The decrease was attributed to the decline in production business of 21.65 million baht,

about 26.23% comparing to same period of the previous year. The decrease due to the volume of service. However, the

advertising revenue in Q3/2019 was 41.27 decreased by 20.72 million baht or 33.43% was attributed to market weakness

in advertising spending which has not fully recovered and economic situation.

Cost of sales and service:

For the 3th quarter ended September 30, 2019, the company had the cost of sales and services was 75.28 million baht which

decrease by 27.13 million baht or 26.49% comparing to the same period of the previous year. The decrease was relative to

the volume of service revenue decline.

Selling and Administrative Ex penses, Other Expenses:

For the 3<sup>rd</sup> quarter ended September 30, 2019, the company had the selling and administrative expenses and other expenses

of 25.49 million baht, which decrease by 1.30 million baht or 4.86% comparing to the same quarter of the previous year.

The decrease was from the expense control.
