For the three-month period ended September 30,2020

The consolidated financial statements of TV Thunder Public Company Limited and its subsidiaries ("the Company") for the three-month ended September 30, 2020 showed total Profit for the period attributable to the equity holders of the parent company is 5.39 million baht, increased of 969.05% from same quarter of the last year. This change can be primarily explained due to:

Revenue:

The company's total revenue in the third quarter of the year 2020 was 76.15 million baht, a decrease of 25.99 million baht or 25.44% compared to the same period last year.

Which is a decrease from advertising revenue of 4.90 million baht, a decrease of 11.88% compared to the same period last year. This is mainly due to the decrease in sales minutes. From the suspension of one program during almost 2 months (Jul-Aug 2020) and one program that has decreased.

And another decreases was service income of 21.09 million baht, a decrease of 34.63% compared to the same period last year. This was mainly due to the decrease in production workloads from various television stations and various events. That decreased more than 81.00% compared to the same period last year.

Cost of sales and service:

The company's total cost of sales in the third quarter of 2020 totaling 50.31 million baht, a decrease from the previous year 24.97 million baht or 33.17%, because of the decrease in advertising sales minutes The quantity of items contracted for production and events decreased

Selling and Administrative Expenses, Other Expenses:

The Company had selling and administrative expenses in the third quarter of 2020 of 18.23 million baht, a decrease of 7.26 million baht or 28.48%, which is a decrease in the operations of 2 subsidiaries that are in the process of company liquidation and from strict cost controls
