The consolidated financial statements of TV Thunder Public Company Limited and its subsidiaries ("the Company") for the three-month period ended September 30, 2016 (Quarter 3/2016) showed total revenue 163.30 million baht. Cost of sales and services amounted to 122.48 million baht. Selling and administrative expenses, other expenses and finance costs were 28.62 million baht. Total Net Income for the period was 13.80 million baht, which increased by 4.74 million baht or 52.36% in the same quarter of the previous year. This changes can be explained primarily due to:

Revenues:

For the 3rd quarter ended September 30, 2016 the company had the total revenue of 163.30 million baht increased

by 6.55 million baht or 4.18% from the same quarter of the previous year which had the total revenue of 156.75 million

baht. The performance can be summarized as follows:

Revenue from advertising

For the 3rd quarter ended September 30, 2016 the company had the revenue from advertising of 109.43 million

baht which decreased by 1.50 million baht or 1.35% from the same quarter of the previous year. The decrease of revenue

mainly came from the overall advertising budgets continue to decline. Such statements are based on Analog TV was lower

than last year, while Digital TV was increased compared to last year.

Revenue from services:

For the 3rd quarter ended September 30, 2016 the company had the revenue from services of 53.87 million baht

which increased by 8.05 million baht or 17.57% from the same quarter of the previous year. The increase was due to the

continued growth in the production of service in digital TV and online platform.

Cost of sales and services:

For the 3rd quarter ended September 30, 2016 the company had the cost of sales and services of 122.48 million

baht which decreased by 5.28 million baht or 4.13% from the same quarter of the previous year. This was mainly due to

the controlling of production cost.

Selling and Administrative Expenses, Other Expenses:

For the 3rd quarter ended September 30, 2016 the company had the selling and administrative expenses and other

expenses of 26.24 million baht increased by 6.20 million baht or 30.96% from the same quarter of the previous year. Mainly

due to the increase of the expenditure of personnel and the expense of the 3 new studios "Green Park Studio".
