Subject: Management Discussion and Analysis

For the year ended December 31,2016

To: The President,

The Stock Exchange of Thailand

The consolidated financial statements of TV Thunder Public Company Limited and its subsidiaries ("the Company") for the year ended December 31, 2016 showed total revenue amounted to 507.57 million baht. Total cost of sales and services amounted to 358.09 million baht. Selling and administrative expenses, other expenses and financial costs amounted to 110.88 million baht. Net Income for the period attributable to the equity holders of the parent company was 48.37 million baht, which decreased by 1.89 million baht or 3.76% from the previous year. This changes can be explained primarily due to:

Revenues:

In 2016, the company had the Total Revenues amounted to 507.57 million baht, which decreased by 17.38 million baht or 3.31% compared to 2015 which had Total Revenues amounted to 524.95 million baht. The decrease was due to:

Revenue from advertising

The advertising revenue amounted to 307.24 million baht decreased by 26.98 million baht or 8.07% compared to 2015. This was mainly from ad spending in 2016, decresed 11% compared to 2015, which resulted in a reduction of spending on analog TV advertising down from the year 2015 amounted to 10,291 million baht or 17.92% (refer: http://positioningmag.com/1112993), and the suspension of the broadcast programs during October to November.

Revenue from service

The service revenue amounted to 200.33 million baht increased by 9.60 million baht or 5.04% compared to 2015. This was mainly from the growth in the production of service in digital TV and online platform.

Cost of sales and services:

Cost of sales and services amounted to 358.09 million baht decreased by 17.47 million bath or 4.65% compared to 2015. This was mainly from advertising costs which suspension of the broadcast programs during October to November.

Selling and Administrative Expenses, Other Expenses and Financial costs:

The selling and administrative expenses and other expenses amounted to 98.56 million baht which increased by 8.79 million baht or 9.79%, compared to 2015. The mainly increase was due to employee expenditure and depreciation from 3 new studios which start using on June 2016.
